#### In exchange for product sponsorship, RECARO Automotive requires the following be provided once the product has been received and installed.

- 1. If RECARO Automotive agrees on sponsoring / part-sponsoring, you have to order the products not later than 6 months after the written "sponsoring confirmation" of RECARO.
- 2. A written testimonial describing why you have chosen the RECARO for your application within (2) months of receipt of the RECARO product(s).
- 3. A minimum of 4 photos to be provided to RECARO for use in advertising, public relations efforts or promotional use within two (2) months of receipt. Photo should include RECARO Logo, product, etc. (Please fill out the attached release form). RECARO also requires a minimum of 4 photos showing the vehicle interior "before" the RECARO product is installed and "after" the RECARO product is installed.
- 4. At least one (1) decal to be placed on the vehicle in a prominent location. If no sponsor decals will be placed on the vehicle, then the RECARO logo and product description will be placed on a sign prominently displayed near the vehicle when the vehicle is on public display.
- 5. Display of product literature and / or signage including the RECARO logo when appropriate at events.
- 6. A minimum of 6 tags and posts to be provided to RECARO Automotive's (#recaroautomotive) Facebook page, Instagram, Twitter to be used in public relations efforts or other promotional use. Posts will be made over the course of 6 months, starting from the date the vehicle is publicly revealed. Photos posted should include RECARO Logo, product, etc. These posts will be made over a 6-month period of time starting from the date the vehicle is revealed publicly. Additional, if videos are created they will be posted to RECARO Automotive YouTube channel (recaroautomotive).
- 7. Sponsoree agrees that the vehicle will not be displayed publicly including; on TV, events, magazine articles, any form of print advertising, social media channels or other public forums with harnesses that show another aftermarket or racing seat / shell manufacturer's logo.

- 11. It is not allowed to make changes on the seats and the sponsoring purpose. All changes need to be approved in written form by the RECARO Marketing department. Please do not remove the FIA- or ABE sticker on the seats. It is not possible to deliver in addition.
